1. INTRODUCTION

The website, "<u>www.quibim.com</u>", "<u>www.quibim.es</u>" and its sub-domains (the "**Website**"), uses technology known as "cookies" in order to gather information on the use of the Website.

As a Website user, we inform you that QUIBIM, S.L. ("**QUIBIM**") is the holder of the domain in which the Website is hosted and uses these cookies to facilitate your use of the Website, distinguish you from other users, offer you a better user experience and identify problems in order to improve the Website.

Should you give your consent, we will use cookies that enable us to gather more information on your preferences and tailor our Website to your individual interests.

2. COOKIES

A cookie is a file that is downloaded on your computer (or mobile device) in order to store data that can be updated and recovered by QUIBIM.

The information gathered using cookies can include the date and time of visits to the Website, the pages viewed, the time spent on the Website and the sites visited just before and just after it, including also alphanumeric codes that allow obtaining this information after its interpretation and/or editing.

By browsing and remaining on the Website, you are consenting to the use of the above cookies, for the time periods established and on the conditions contained in the Cookies Policy.

3. TYPE OF COOKIES USED ON THE WEBSITE

The Website uses the cookies described below:

A. In-house cookies

These cookies are sent to your computer and managed solely by QUIBIM to ensure the better functioning of the Website. The information gathered is used to improve the quality of our service and enhance your user experience. These cookies remain in your browser for longer, allowing us to recognize you as a repeat visitor to the Website and adapt its content to offer you content in line with your preferences.

B. Third-party analytics cookies

The Website also uses the traffic measuring system Google Analytics, a Google web analysis tool that allows to measure how users interact with the Website.

Likewise, the Website allows the authentication of users through its personal account of Linkedin. This authentication uses the *oauth2* technology that requires the use of cookies to improve the user experience. Also, it is possible to find cookies from *Stripe*, that is, the payment management service that is integrated in the Website. This service uses identifiers aimed at increasing the security of your service.

It also sets cookies on the domain of the site the user is visiting and uses a set of cookies known as "__utma" and "__utmz" to gather information anonymously and to report Website trends without identifying individual users.

Together with our server logs, they enable us to ascertain the total number of users visiting the Website and the most popular areas. Thanks to them, we can obtain information that helps us to improve browsing and offer a better service to users and clients.

If you interact with the content of the Website, third-party cookies may also be installed. Third-party cookies are those established by a domain different to the Website. QUIBIM cannot access to the data stored in cookies of other websites when you browse these other websites.

C. Other third-party cookies

Other third-party cookies necessary to make use of external applications on our website; for example, those used by social networks (such as Twitter, Facebook, Linkedin, Youtube or Instagram) or by external content plug-ins (such as Google Maps). In addition, some advertising companies use these types of files to track your visits to each site on which they advertise.

4. DISABLING AND BLOCKING COOKIES

In any case, since cookies are not necessary for the use of the Website, please note that you can block or disable them by configuring your browser to allow you to block the installation of some or all cookies.

Almost all browsers allow you to be alerted to the presence of cookies or block them automatically. If you block cookies, you can continue to use the Website, although some services may be limited and your experience on the Website may be less satisfactory as a result.
